Thomas gave a brief description of the proposed lagoon sludge treatment plan to apply chemicals to reduce the amount of sludge in the holding ponds.

A motion was made by Bertke, second by Branch to approve the treatment program as outlined by Environmental Technologies for approximately \$30,000 per year. Roll call resulted in the following ayes: Branch, Ahrens, Kessen, Bertke, and Brunswick. Motion carried.
