Reports:

Finance Director: Eyink distributed the cash position report and the income tax report. He said the State Auditor has finalized the audit for the Village. There were no changes since he last spoke about it in June. He also recommended we schedule a Finance Committee meeting to look at the budget.

Manager/Engineer: Thomas said the ODOT paving project of State Route 118 and State Route 219 should have been finished by now. The contractor has encountered several delays. He said the county had a speed study completed on Burkettsville-St Henry Road near the Village. At this time the study did not warrant a reduction in the speed limit. Mayor: Knapschaefer said he recently attended a Mayor's meeting in Sidney. They had a discussion about Jobs Ohio. He said the meeting was very informative, they are planning another meeting in March.
